### **Priority fields of action:**

1. Better management of water resources and demand;



2. improved rational use of **energy**, increased renewable energy use and mitigation of and adaptation to climate change.

3. Sustainable **mobility** through appropriate transport management;

- 4. Sustainable tourism as a leading economic sector;
- 5. Sustainable agriculture and rural development;
- 6. Sustainable urban development; and

7. Sustainable management of the **sea**, **coastal areas and marine resources**.

### MSSD revision preliminary roadmap

Between January 2014 and February 2015 : 3 to 5 expert group meetings to draft MSSD 2.0. MSSD to be consulted for guidance / comments electronically during the process. Virtual platform will be put online to facilitate collaboration.

April 2015 : Draft MSSD 2.0 submitted to MAP Focal Points meeting for initial comments.

May 2015 : Expert group meeting to integrate comments and propose a new MSSD 2.0 draft

June 2015 : MSSD 2.0 Draft submitted to MCSD meeting for finalization.


September 2015 : MSSD 2.0 submitted to MAP focal point meeting
