Background

About SCP/RAC

The Regional Activity Centre for Sustainable Consumption and Production (hereinafter SCP/RAC) is a centre for international cooperation on development and innovation based on the sustainable consumption and production approach (hereinafter SCP).

The Centre is one of the Regional Activity Centres established in the framework of UNEP/ <u>Mediterranean Action Plan (hereinafter UNEP/MAP)</u>¹, the programme of UN Environment established to support the member countries of the Barcelona Convention. Under that institutional framework, SCP/RAC has an official mandate from the countries as centre that engages in international cooperation with Mediterranean countries on development and innovation in the business sector.

The Centre is based in Barcelona and it is legally hosted by the Catalan Waste Agency, a public service agency considered a reference organization in waste prevention and management and the promotion of circular economy.

Framework of the assignment of this ToR

A Cooperation Agreement between UNEP/Mediterranean Action Plan and the Italian Ministry for Environment Land and Sea Protection (IMELS); hereinafter referred to as the Cooperation Agreement; was signed in September 2016 providing for a framework of cooperation to support the implementation of the UNEP/MAP Mid-Term Strategy 2016-2021. The Cooperation Agreement focuses on 4 main Components, one of which is the enhancement of marine litter management. In this respect, financial support has been provided by the IMELS for the implementation of a number of activities included in the UNEP/MAP Programme of Work (PoW) 2018-2019, adopted by the Contracting Parties to the Barcelona Convention in their COP 20 (Tirana, Albania, December 2017).

In this context, under the PoW Activity 2.2.1.5. "Develop Guideline and training material to prevent the generation of plastics and wastes ending up as marine litter" SCP/RAC is developing a set of policy guidelines addressing single-use plastics, particularly related to food and beverage packaging, through green public procurement.

This activity is part of the overall portfolio of activities led by SCP/RAC with support from both IMELS and EBRD², with the objective of *Improving the policy framework and engaging with the food & beverage industry in Albania, Bosnia and Herzegovina and Montenegro for tackling*

plastics packaging value chains in a circular economy. This set of activities aims at contributing to the identification and prioritization of preventive measures that tackle plastic packaging in the food and beverage (F&B) industry³, by:

- Improving the relevant policy framework
- Strengthening the engagement of businesses and business support organizations (BSOs).

Plastic and plastic packaging, an issue of increasing concern

Plastics and plastic packaging are a valuable resource that brings numerous benefits to modern society and they have become an integral and important part of the global economy. According to the Ellen McArthur Foundation, plastic production has exponentially increased, from 15 million tons in 1964 to 311 million tons in 2014, and it is expected to double over the next 20 years. Today, plastic packaging is the largest application of plastics - it represents 26% of the total volume of plastic used. Globally, 95% of plastic packaging material value, estimated at EUR 70-105 billion annually, is lost to the economy after a very short first use-cycle.

Each year, at least 8 million tons of plastics end up in the ocean⁴. Marine litter is a growing problem that has attracted significant public attention over recent years. In the Mediterranean sea, the concentration of marine litter is comparable to that found in the 5 gyres, and plastic comprise up to 95% of the waste accumulated on shorelines, the sea surface or the sea floor⁵.

According to Eunomia, nearly 60% of the plastic waste generated in the EU in 2015 came from packaging, out of which a very high proportion is food and beverage packaging. The trend is towards a significant increase, for example, Smithers Pira estimates that Europe will consume more than 900 billion items of packaged food and drink annually by 2020. In particular, the retail sector is seeing strong packaging penetration rates, growing from 63.0% in 2010 to 66.0% in 2014, with key areas including fresh fruit and vegetables, fresh meat and fish, chilled foods and baked products.

It is therefore of utmost importance to include policy makers, industry and business community in a multi-stakeholder dialogue to identify challenges and specific actions on the issue of plastics ending up as marine litter. The F&B industry is a key stakeholder in providing innovative and transformational solutions to the problem of plastic waste, while also affecting the policy set-up within and around their operations. Moreover, it is an aggregator and multiplicator for best practices, in view of its work with supply chain partners and industry

associations to explore different packaging solutions that create a circular economy for plastic packaging.

Public procurement as a tool to prevent plastic packaging

According to the UNEP global review of SPP in 2017: "Procurement processes that consider social, economic and environmental factors are able to drive sustainability along value chains." This was acknowledged by the international community when it included a target on sustainable public procurement in the Sustainable Development Goals.

The procurement cycle offers wide opportunities to tackle throughout all the value chain the problematic of plastics. GPP stimulates eco-design, eco-innovation, secondary raw material market, greater trust in recycled plastics (both from manufacturers and end users).

In public administrations, plastics relate to different services and uses, including:

- Packaging all categories
- Catering & hospitality
- Cleaning
- Facilities management
- Construction

Green Public Procurement (GPP) addresses this topic commonly through food and services where plastic packaging and plastic items can be tackled the most as they use potentially a wider majority of items. Considering the overall approach of SCP/RAC in conducting activities in the Western Balkans, catering & hospitality services is an area of major interest to drive the food and beverage sector to more responsible packaging. However the other sectors shall be considered as well within this assignment.

We can find important reference manuals such as the Procura+ Manual: A Guide to Implementing Sustainable Procurement (3rd edition⁶) which includes specific criteria addressing plastic packaging waste in the procurement of food and catering services. These relate for example to the "Use of packaging from recycled or renewable sources which can be reused or recycled after use". This is considered under the award criteria "Approach to reducing food and packaging waste"

The Manual identifies the following best practices and/or guidelines related to food services.

In addition, the EC has produced several documents and guidelines on GPP, including "Food and Catering Services Background. Product Report"⁷, and again the issue of plastics packaging and plastic items is mainly addressed in the food and catering services sector. In general, contracting authorities purchase catering services on a regular basis, for example, in schools, hospitals or office canteens, or for events such as conferences, meetings or festivities. Therefore by tackling this sector, we are addressing the majority of packaging plastic items used by public administrations. However the use of plastic packaging and its environmental effects has not been a major issue addressed in food and catering procurement, including through guidelines.

Objective

The objective of this consultancy is to produce a policy guidelines document addressing the promotion of non-single-use plastics, including both items and packaging, through green public procurement. Additionally, the promotion of such guidelines should raise awareness of public authorities at this regard and transition towards a sound use of plastic. These guidelines shall take into account the European Strategy for Plastics in a Circular economy, and the geographical scope should be the Mediterranean region (Barcelona Convention).

This work complements the SCP/RAC mandate on public policy on the issue of plastics, mainly through the regional guidelines for phasing out single-use plastic bags in the Mediterranean region, developed in the Marine Litter Med project⁸.

This activity supports the implementation of the Regional Plan on Marine Litter Management in the Mediterranean, adopted in 2013 (COP 18, Decision IG.21/7) as well as the Regional Action Plan on Sustainable Consumption and Production in the Mediterranean adopted in 2016 (COP 19, Decision IG.22/5).

Description of work

This assignment will focus on GPP related to plastic products and plastic packaging (including waste management), with special emphasis on food and beverage services.

Activity 1. Elaboration of Guidelines on tackling single-use plastics through public procurement

In order to elaborate such guidelines, the Consultant should consider the following elements:

- Revision the policy gap study undertaken in a previous phase of the project and build on the results from the: "Stocktake and analysis of other existing policy instruments relevant for tackling plastics in the F&B sector" GPP/SPP measures. (This document will be facilitated by SCP/RAC in due time⁹). This will provide background knowledge for the 3 participating countries.
- 2. Identify background elements for the policy guidelines document which may include:
 - An overview of how GPP plays or could play a role in the EU Plastic Strategy and other frameworks such as the Barcelona Convention, considering the Regional Plan on Marine Litter Management in the Mediterranean and the Regional Action Plan on Sustainable Consumption and Production in the Mediterranean
 - Identification of all actors and processes in public administration related to singleuse plastic products and packaging, such as staff, suppliers and contractors, public, packaging, catering and hospitality, cleaning, facilities management, construction, commercial collection and On the Go.
 - State of the art of best practices and case studies of GPP in relation to plastics and particularly to food and beverages considering the above.
- 3. Propose the structure and draft content of the policy guidelines, including a step-bystep implementation approach. Such document shall include specific recommendations for three countries that make the scope of this consultancy.
- 4. In addition to the elaboration of the guidelines document, SCP/RAC will recruit a national expert to conduct a pilot project to reduce the single use of plastic in selected public administrations (in Montenegro), providing advice on prevention options and

implementation of action. The Consultant should liaise with that national expert to respectively feed both assignments.

Activity 2. Attendance to a regional workshop in 2019. Within the overall assignment, national and regional workshops will be organized and the Consultant should be available to provide a presentation on the work at one of them. The date and venue are to be determined; tentatively this event should take place in October-November 2019.

Deliverables and calendar

The Consultant's team will start the work after the validation of their offer by the contractor.

All the deliverables will have to be presented in English and validated by the Contractor, within 1 week after the submission, before moving to the next step of the assignment. Failure in submitting deliverables or not reaching enough quality may result in a reduced budget allocation. In addition, regular calls will be organized with the contractor

Means of work and eligible costs

This work should be conducted through literature review and consultation with stakeholders. Equipment, consumables, travel should be included in the financial offer as a lump sum, with the exception of the travel and accomodation expenses for the attendance to national/regional workshop (organized by the Contractor), which will be covered by the Contractor.

Eligibility

Applicants must fulfill the following requirements:

- Be an individual consultant, firm or association. Note: This ToR is not a subvention but a provision of services.
- Be able to comply with national fiscal context and rules for receipt of international funds.
- Have a bank account whose holder name must be the same as the applicant.
- Partnership and subcontracting are allowed, provided that the legal applicant entity has a substantial role in implementing the assignment. The applicant will be the only legal entity with which the contract relation will be established.

- Academic background in public administrations, law, environmental science or similar
- Fluent communication in English (oral and written)
- Extensive experience in public procurement policies and waste management
- Experience in international projects

How to apply and selection process

Candidates should submit the following documents:

- Technical and financial offer (maximum 4 pages, see form as Annex): the Consultant should elaborate a specific methodology to conduct the work based on the content suggested in section: "description of work", elaborating it further. An implementation calendar should be delivered, including planned consultation with key stakeholders. Financial offer: the consultant(s) should state the personnel dedication expressed in days (1 day = 8 working hours) as well as a lump sum for other costs related to the implementation of work.
- Profile and project references (maximum 2 pages): the consultant(s) should submit a brief explanation of the candidate (CVs shall be included as annex) and project references on the topic.
- 3) Bank form filled in, signed and stamp by the bank (see form as Annex).
