In 1975, the Mediterranean Action Plan (MAP) is adopted by the Mediterranean countries under UNEP's umbrella. In 1976 the Parties adopted the Convention for the Protection of the Mediterranean Sea Against Pollution (Barcelona Convention)



7 **Regional Activity Centers** which carry out environmental related activities and a coordinating unit form part of the MAP.

In 2009, The RAC/CP was designated Regional Centre for the Stockholm Convention

### A global common challenge...



Production-oriented strategies do not address the increasingly significant environmental and social impacts associated with the selection, use and disposal of products by consumers.



Economies can not be sustainable if efforts to make production processes more environmentally-friendly are not accompanied by a society-wide shift to sustainable consumption patterns.

Without sustainability actions, by 2100 we would need the resources of four planets at current consumption rates and population growth (UNEP)

#### **Substitution of BFRs: PAXYMER**



- Free of POPs (No PBDE, HBCD, DecaBDE, etc)
- No persistent, bio-accumulating or toxic characteristics (PBT)
- No carcinogenic, mutagenic or reprotoxic characteristics
- Improved burning performance and elimination of HBr smoke

Full reciclability of the product: Substances with BFR won't be able to be recycled (after exemption finishes) or exported



#### SUBSTITUTION OF PFOS: RUDOLF GROUP



- Fluorocarbon-free waterproofing agent
- Same water-repellent effects as Fluorocarbons
- low curing temperatures
- very good washfastness
- better abrasion-resistance than fluorocarbons
- Entire LCA has no risk for health and is environmentally friendly
- No oil- or blood repellency

# COCO-MAT: Only natural materials





- -Mattresses, bases, pillows, duvets, bed linen, towels and furniture for homes and hotels exclusively made from natural products with **no chemical additives**. Only ecological, non-toxic, non-aggressive dyes are used.
- -Raw materials: Coco fiber, Natural rubber, Ecological cotton, Seaweed, Horse hair, Goose down, Cactus, Lavender, Wood, Wool, Silk and Linen.
- Fire-test certification approved for hotel matresses (USA).

# Why substitute / eliminate hazardous substances?



- Legislation requires substitution in specific cases and recommends it in general
- Protect workers, consumers, downstream users and the environment
- Business partners and financers prefer safer alternatives!!
- Green chemistry is a growing trend generating more and more solutions



#### SUBSPORT INITIATIVE











- Compilation of legal texts with substitution issues
- Access to information about substances banned or restricted (or proposed to) by authorities, companies, NGOs, or trade unions.
- Presentation of different substitution tools.
- Different case studies to learn from others' experiences.
- Substitution examples can be a starting point in finding alternatives
- SUBSPORT can also be used for general chemical management with useful information and links provided.




### Training activities on substitution
